

Beth Tweddle Gymnastics Bolton Competition

TERMS AND CONDITIONS

The Promoter: BETH TWEDDLE GYMNASTICS

Entrant: This competition is open to residents in the United Kingdom and individuals aged 18 or over, excluding employees of Beth Tweddle Gymnastics or its affiliate companies, their families, cohabitants, agents and anyone connected to the brand.

Data: Any personal data submitted may be generated and administered by the Promoter and you agree to them storing and using your personal data for the purposes of administering each contest.
Competition Period: Each Entrant may enter the competition between 00.01 on 14/04/21 and 23.59 on 14/05/21.

To Enter: Users must submit their own name and email address, plus the name and age of the nominated child to enter. The child nominated must have permission from their parent or guardian to take the lessons if this is not the nominee.

1 (one) entry is allowed per person.
